Archdiocesan Council President Election Nomination Deadline:

- Deadline to submit nominations to our Council Office is April 15, 2025.
- Names of persons nominated, who agree to serve if elected and meet the requirements of this position, and their autobiographical statement and a platform will then be submitted to all District Presidents before May 1, 2025.
- District Presidents will share candidates' information within their District Conferences and ask each Conference to prayerfully discern their choice. Voting will take place via secret ballot at the **July 14**, **2025** Council Board meeting.
- The person having the majority of the votes will be duly elected; Conferences will be notified by July 18, 2025.


ONE SOCIETY DEADLINE EXTENSION

Case Management Systems (CMS) Archiving Records

SVdP's Record Retention Policy

During operation, Conferences generate case records, bank statements, invoices, etc. Confidentiality demands that all records on individuals and families served be kept in a secure, private place. Electronic records maintained in CMS are considered secure and private for purposes of record retention.

Data Management Practices Checklist

Data Entry - Vincentians

- Minimize handling and sharing: SS#s, DL#s, Passport #s, bank account #s, credit card #s, etc. Do NOT record unless grant requirement and discuss with Council how to safely record.
- o Do NOT document medical info. Use: "Health is an issue in this case."
- o Do NOT mention immigration status.
- o Do NOT retain neighbor documents on personal hard drives.
- Minimize sharing personal information and PDFs in email and texts
- o Delete email and text strings after case is closed. Review monthly
- Delete paper and electronic records annually per retention guidelines (3 years for case records & 7 years for financial records)
