

Archdiocesan Council President Election Timeline:

- The deadline to submit nominations to our Council Office is April 15, 2025.
- Names of persons nominated, who agree to serve if elected and meet the requirements of this position, will be submitted to all District Presidents by May 1, 2025. All

nominees will complete an Autobiographical Statement and Platform Statement that will be distributed.

- District Presidents will share candidate information within their District Conferences and ask that each Conference prayerfully discern their choice for Council President and communicate their vote to their District President who will vote by secret ballot at the July 14, 2025 Council Board meeting.
- The person having the majority of the votes will be duly elected and Conferences will be so notified by July 18, 2025.

This timeline will allow the newly elected Council President to "shadow" the incumbent President for a couple of months so that there is a smooth transition of responsibilities and will allow the new President to attend the National SVDP meeting in late August.

Nominee Autobiographical Statement

Elections for Districts 4 & 6

The election of Conference Presidents will take place no later than **March 31st**.

This may be a normally scheduled meeting or a special meeting.

A process for breaking a tie must be established before the vote occurs.

Voting is done in the form of a secret written ballot.

The Chairperson of the Nominating Committee will present the candidates, distribute the ballots to the Conference Presidents (within that District), and collect the filled in ballots. If established in advance, mail-in votes may be acceptable and would be included. Members of the committee will count the ballots and report results to the Committee

Chairperson.

The Committee Chairperson will then reveal the name of the person elected to the office of Archdiocesan Council President.

At no time will the ballot count be revealed to the members or the candidates.

If there are more than two candidates, the candidate who receives more than 50% of the total ballots cast becomes the President-Elect.

If none of the candidates receives this simple majority, the Committee Chairperson will announce the two candidates with the most votes and there will then be a runoff election held as soon as possible.

There are times when only a single candidate comes forward and when this this occurs, the election process must still be followed and must still be a secret ballot.

A "yes" or "no" vote must be cast; only the votes cast are counted.

If the single candidate does not receive a simple majority of approval, then the Nominating Committee must find other candidates.

Should there be no qualified candidates interested in the role of District Council President by **January 1st** when the Nominating Committee has to submit the names of candidates to the Conferences, then the Archdiocesan Council President is to be notified; the District will need to be disbanded and the Conferences report to other District Councils.

The Archdiocesan Council President will be responsible for working with the District Conferences discussing options for the District and will need the months of January through May to explore options.

FINANCE COUNCIL

GOOD FINANCIAL PRACTICES

AUDIT TIME

The Society of St. Vincent de Paul is a Vincentian-led organization that has the same financial functions as a business. It recognizes revenues, incurs expenses, and provides monetary support to numerous families in need of financial assistance. In addition to Conference Treasurers, the Society has a Council Finance Department for oversight to review, process, and record financial transactions.

Annually, the Board of Directors, along with the Finance Committee, approves a report of financial activity, which is required to be audited and reviewed by a certified public accounting firm. This independent external audit includes assessing internal controls, compiling financial statements and related disclosures, and testing a sample of financial transactions (both at the council and conference level) of the past fiscal year. Additionally, the audit tests compliance with the single audit requirements related to applicable federal programs which include the food we receive from the USDA.

Submitting Conference Reports on time ensures successful auditing. All Conference reports must be *completed by the 30th of the following month.* The Finance team strongly encourages all conferences to submit your report by the 20th of the following month to help ensure a successful consolidation of the results.
